

TOWN OF JONESBORO

**ORDINANCE NUMBER 2020-005**

An ordinance amending Section 2-70 of Chapter 2 of the Code of Ordinances of the Town of Jonesboro fixing the compensation for the Board of Aldermen; providing effective date therefore and providing for matters related thereto.

**WHEREAS**, the compensation of the Board of Aldermen is required to be set by Ordinance; and,

**WHEREAS**, the Town desires to maintain the present situation where the compensation is fixed by ordinance and,

**NOW THEREFORE**, be it ordained by the Mayor and Board of Aldermen of the Town of Jonesboro in legal session duly convened as follows:

SECTION I

Section 2-70 of the Code of Ordinances of the Town of Jonesboro be and the same is hereby amended to read as follows:

Section 2-70 - The compensation for the Board of Aldermen be and the same is hereby fixed at the rate of 700.00 per month during the period of their service.

SECTION II

This ordinance shall go into effect immediately upon its passage.

SECTION III

All ordinances or parts of ordinances in conflict herewith are repealed as of the effective date of this ordinance.

SECTION IV

**BE IT FINALLY ORDAINED** by the Mayor and Board of Aldermen of the Town of Jonesboro that if any item or provision including any section, exception, part, phrase or term. Or the application thereof is held invalid; the application to other persons or circumstances shall not be affected thereby. If any phrase, clause, word or other portion of this ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, the invalidity shall be limited t that portion of the ordinance.

The above ordinance was introduced by Stringer at the regular meeting of the Board of Aldermen held on the 14<sup>th</sup> day of July, 2020, and copies of the same were provided to all members of the Board and the Mayor.

THUS ADOPTED at the regular meeting of the Mayor and Board of Aldermen of the Town of Jonesboro on the 11th day of August, 2020, following a public hearing on said ORDINANCE, by the following vote:
